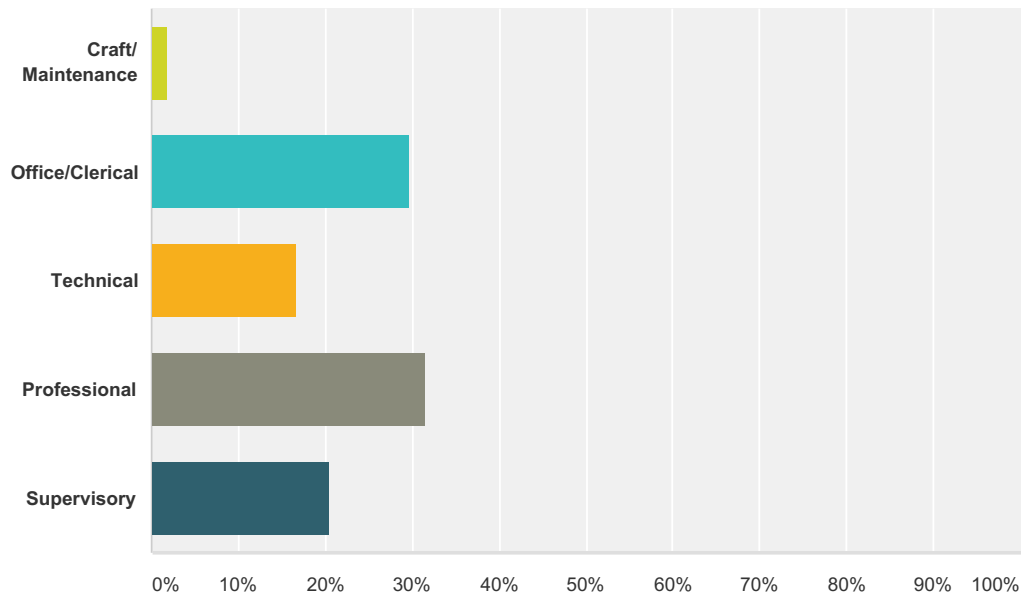

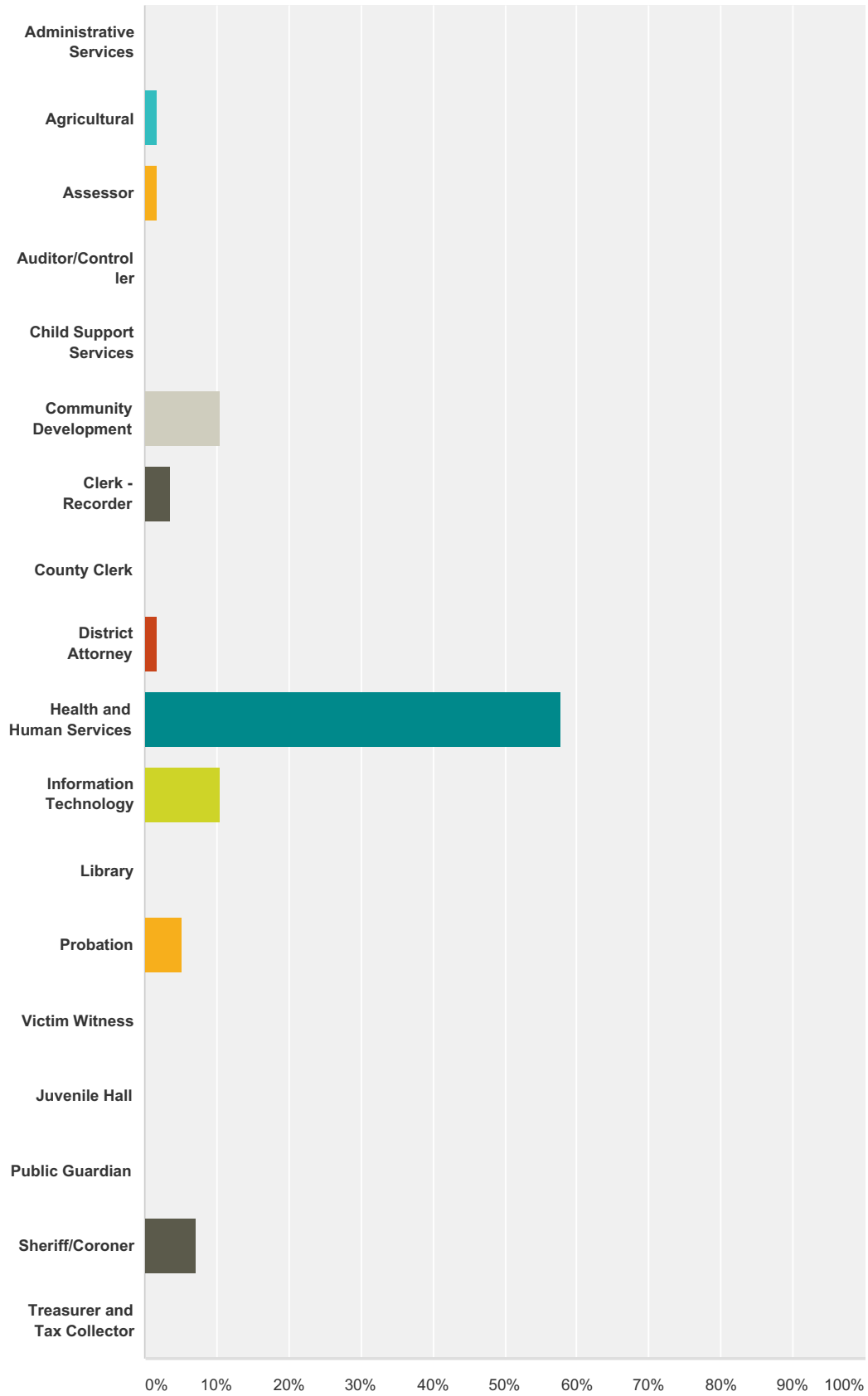

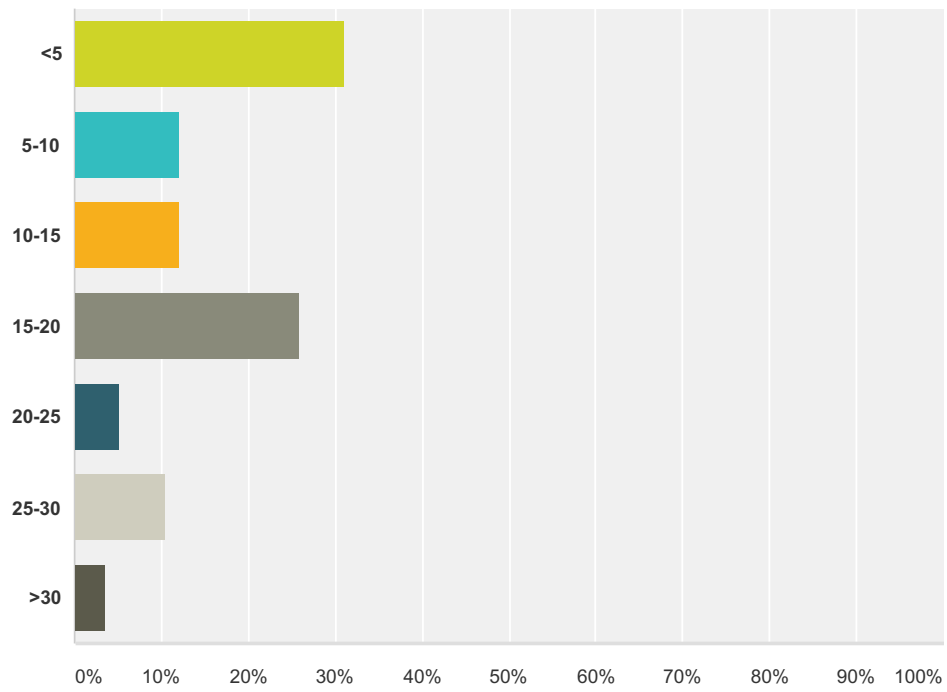

Q6 Generally, what is your length of service with Yuba County?

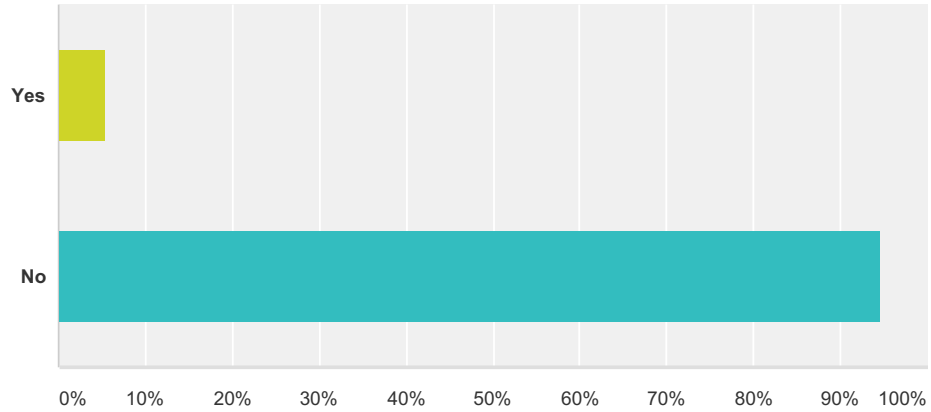

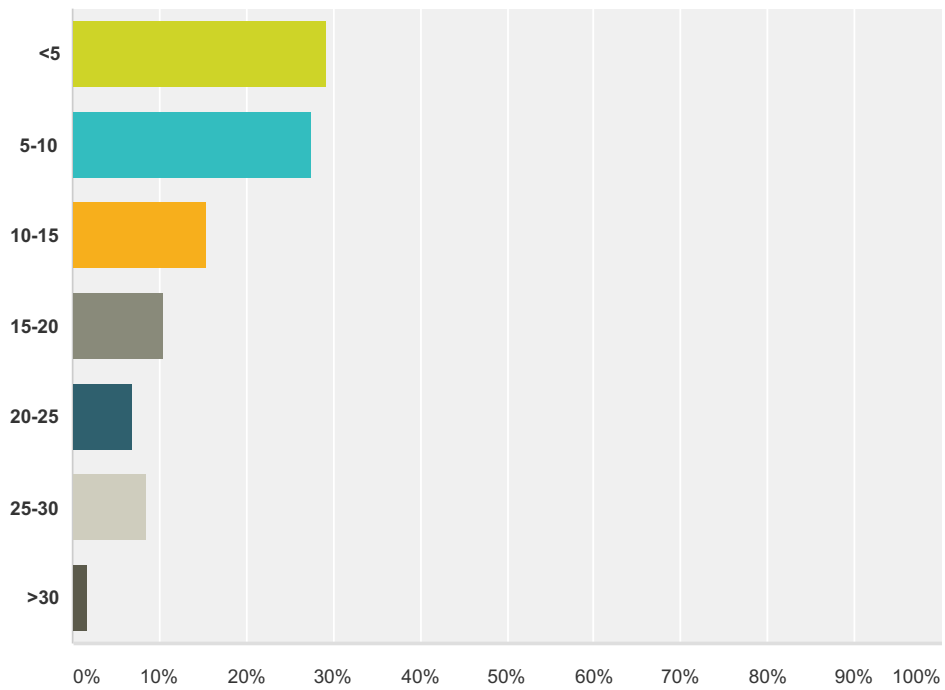

Q9 How many years do you have in Social Security with a prior employer?

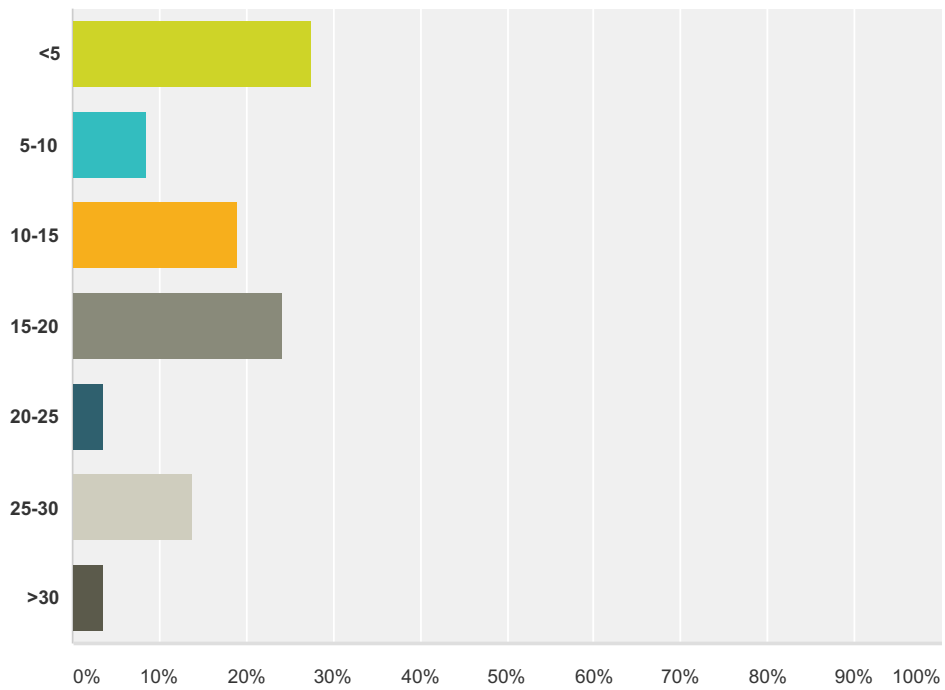

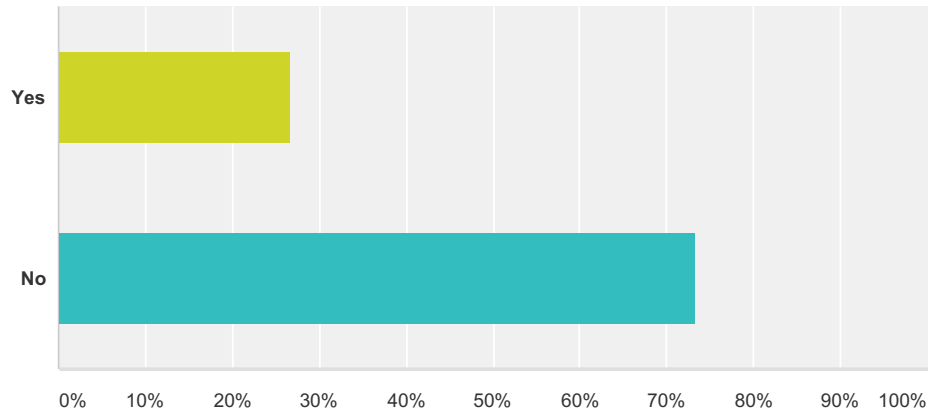

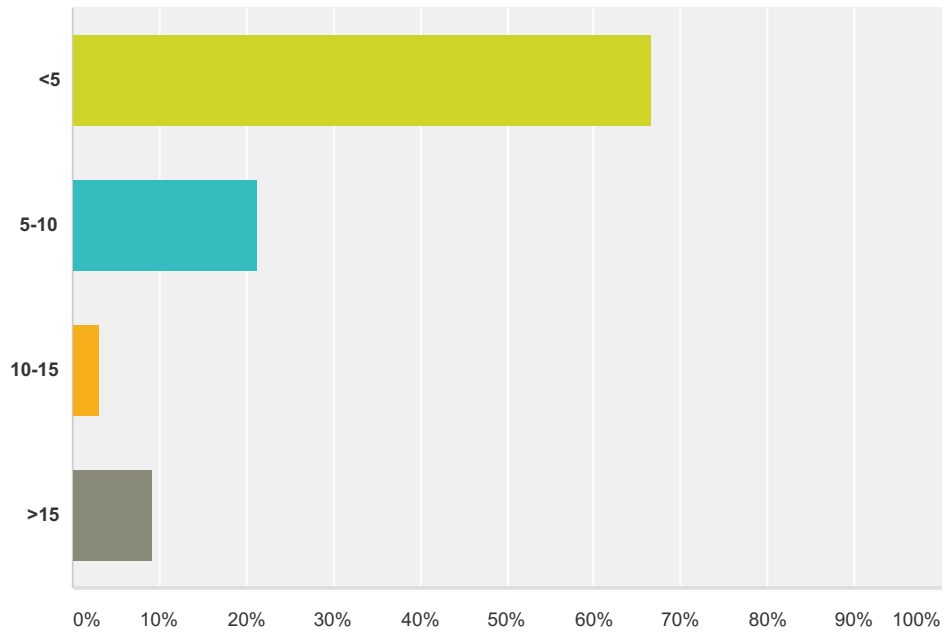

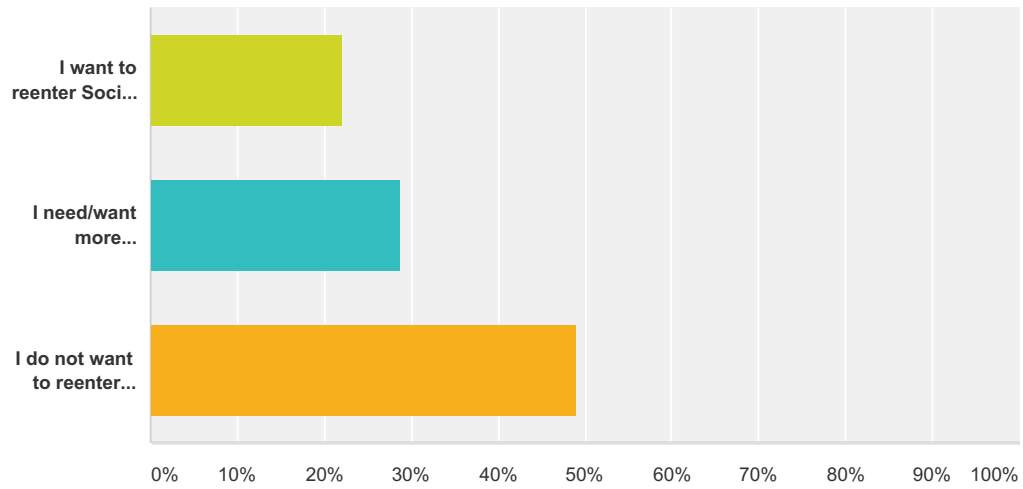

Q14 Based upon your current circumstances and projected future work plan, do you:

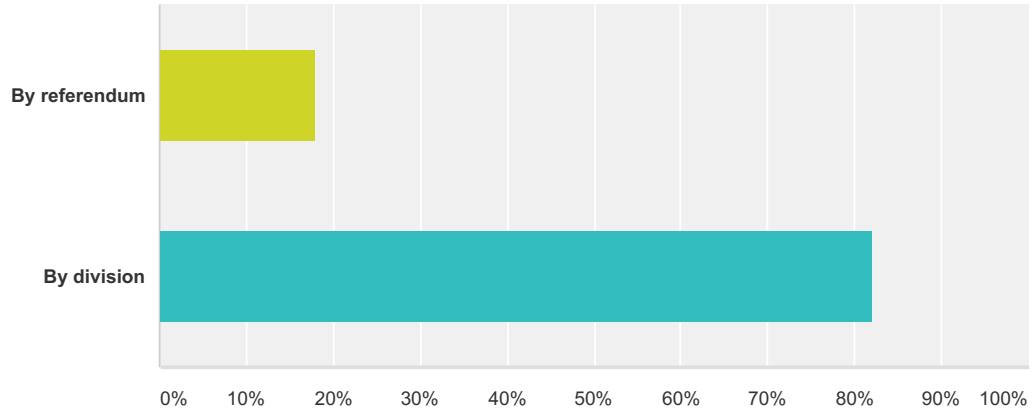
